a. Tank site acquisition – The General Manager reported that the Mitigated Negative Declaration is out for review.

10. Empire Capital "The Retreat CFD #3".

- a. Project Update The General Manager reported that the remaining lots owned by the bank are being looked at by 3 developers.

11. KB Home "Canyon Oaks" (Painted Hills No. 2).
